Building Permit Information

Permits are required for projects over **\$1,000.00**. The term "building" shall include erection, enlargement, alteration, repair or maintenance of any structure: installation, siding, roofing, or alteration of any plumbing, heating or electrical system; any moving or demolishing of structure; or any operation affecting the value of real property within the Township. Please contact the Clerk/Treasurer for more information and to obtain the building permit. Building permits are good for one (1) year.

PLEASE PLAN AHEAD...Building permits for garages, storage sheds, or any other type of outbuilding or home addition require you to have Sheboygan County Planning's approval first. This process can take time, make arrangements before you start construction so delays won't cause you any inconvenience. Their number is 459-3060. They will need a drawing of the new building along with the existing buildings. After you receive their approval, the Town can issue a building permit.

Plumbing & Electrical Permits –

Electrical permits are required for new service or up-grades of \$1,000.00 or more.

Plumbing permits are required for the moving or relocating of existing plumbing & construction of new plumbing.

Permit fees are as follows: New Home – \$575.00; Remodeling – \$25.00; and Plumbing/Electrical – \$100.00

Reminder - Snow Removal Season is Here

DO NOT plow snow across the road or into the opposite ditch. Shoveling, blowing or plowing snow from driveways or parking lots into town roads (including pushing snow across the road) can cause serious traffic hazards. Plowing into the public roadway creates unnecessary hazards for motorists and pedestrians and causes increased time and effort into cleaning or re-plowing the roads. This is a safety issue and re-plowing is **NOT** a good use of tax dollars!

TAX PAYMENT INFORMATION

NO PAYMENTS are to be made at the house, except by mail, N6152 Riverview Road, Plymouth WI 53073. If you are requesting a RECEIPT, please enclose a SELF ADDRESSED STAMPED ENVELOPE, with your payment. Hours for payment will be at the Plymouth Town Hall, 120 Suhrke Road during regular town hall hours – TUESDAYS, 8:30AM TO 12:30PM AND THURSDAYS, 1:00PM TO 5:00PM, with additional hours on Wednesday, December 30, 9:00AM to 5:00PM.

FIRST INSTALLMENT PAYMENTS WILL ALSO BE ACCEPTED AT BANK FIRST NATIONAL, 2323 EASTERN AVENUE, PLYMOUTH (Plymouth Branch Only). PAYMENTS WILL BE ACCEPTED IN THEIR LOBBY ONLY! PLEASE BRING YOUR TAX BILL WITH YOUR PAYMENT. BUSINESS HOURS ARE: MONDAY – FRIDAY, 8:30 – 5:00 and SATURDAY, 9:00 – NOON.

Real Estate Taxes may be paid semi-annually without penalty or interest if the 1st half payment is made by January 31, 2016, balance payable no later than July 31, 2016 to Sheboygan County Treasurer, Sheboygan County Administration Building, 508 New York Avenue, Sheboygan, WI 53081.

Personal Property Taxes must be paid in full by January 31, 2016.

All dogs that are 5 months or older **MUST** be licensed before April 1, 2016. License fee for male & female dogs are \$14.00 and spayed or neutered dogs are \$7.00. Multiple dogs are \$55.00. **NO DOG LICENSE WILL BE ISSUED UNLESS A VACCINATION SLIP IS SHOWN FOR PROOF OF RABIES VACCINATION.** Be sure to include dog license fee and vaccination slip.

Make checks payable to: Laura S. Raeder, Clerk/Treas., Town of Plymouth, for first half of taxes, personal property taxes and dog licenses.

2016 ELECTIONS

Mark your calendar for 2016 Election Dates:

- February 16, 2016 – Primary Election
- April 5, 2016 – Spring Presidential Preference
- August 9, 2016 – Partisan Primary
- November 8, 2016 – Fall General Election

PROOF OF RESIDENCE

You must reside at your residence for 28 consecutive days to be eligible to vote in an election in that municipality. Proof of residence is required with all voter registrations whether you are sending it in by mail, in person or at the Polling Place.

DO YOU NEED TO REGISTER TO VOTE?

Name change, address change or first time voter, you are required to fill out Wisconsin Voter Registration Application for GAB-131 before you vote. Located at www.gab.wi.gov or contact the Town Clerk/Treasurer.

VOTER ID IS REQUIRED

Election will be held on April 5, 2016 for the offices of: (2) Town Board Supervisors – Incumbents are: Roger Rortvedt and Eugene Blindauer. The term of office is for two years, beginning April 19, 2016. If a Primary is needed it would be held February 16, 2016. Nomination papers can begin to be circulated December 1, 2015.
